- iii. The educational agency shall abide by all the orders and instructions issued by the authorities concerned from time to time;
- iv. The educational agency shall abide by the provisions contained in the Tamil Nadu Tamil Learning Act, 2006 (Tamil Nadu Act 13 of 2006) and the rules framed there under;
- v. The educational agency shall abide by the provisions contained in the Tamil Nadu

Schools (Regulation of Collection of Fee) Act,2009 (Tamil Nadu Act 22 of 2009) and the rules framed there under;

- vi. The educational agency shall abide by the provisions contained in the Right of Children to Free and Compulsory Education Act, 2009 (Central Act 35 of 2009) and the Tamil Nadu Right of Children to Free and Compulsory Education Rules, 2011.

3. If it is found at any point of time that the educational agency has violated any of the conditions prescribed for recognition or any of the provisions of the above said Acts and Rules, the renewal of recognition granted shall be liable to be withdrawn permanently.

4. The competent authority also affiliates the above said school to the concern Board of School Education

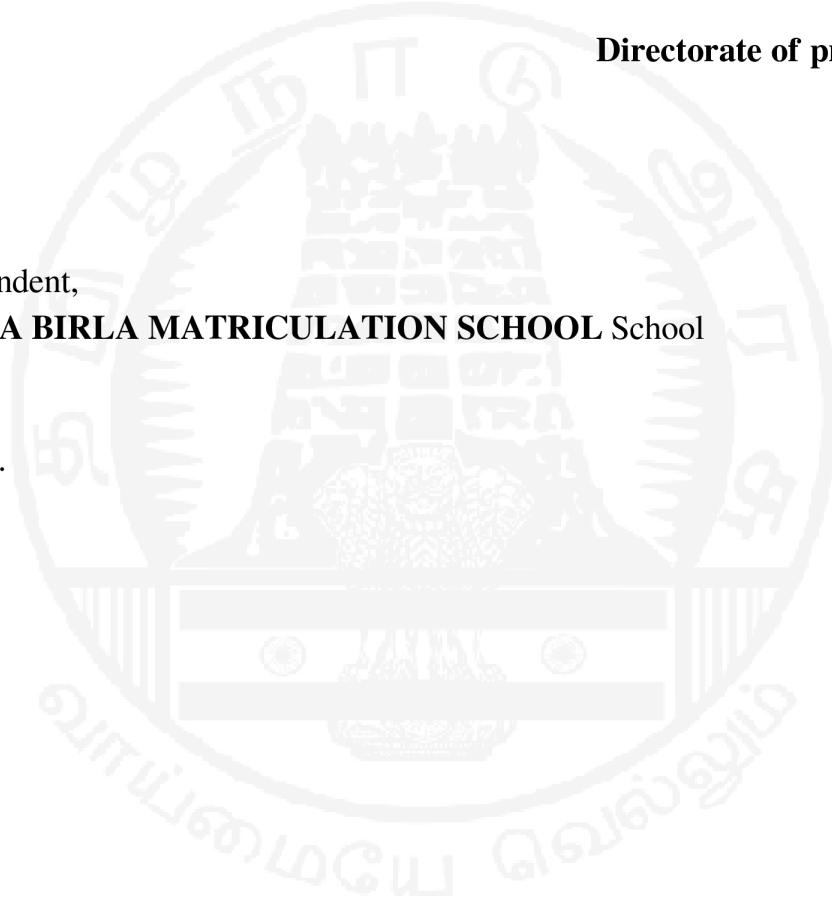
