1. This Proposal has been filed by applicant school to determine fees for the year 2024 – 25, 2025 – 26 & 2026 – 27.
2. Applicant school is affiliated with CBSE Board.
3. School is English medium school.
4. School is situated at same as above.
5. This Proposal is for Std. Pre-Primary to 12th (Gen.) (Sci.).
6. This school is registered with 24210402504 U – dise number.
7. School has filed this proposal on 20-10-2023 to determine fees for the year 2024 – 25, 2025 – 26 & 2026 – 27. We have gone through the proposal files and determined the provisional fees on 15/03/2024. On 16/03/2024, school sent Mr. Vishal Salvi, Authorized Person of the school to collect the said order on behalf of the school. Being aggrieved by the said order the school has filed its objection against the order of provisional fees dated 19/03/2024. On the same date, school also requested via letter that set the physical hearing to revise the fees structure determined by the FRC. On 05/04/2025, school submitted the documents requested by the Committee.
8. On 23/04/2024 Mr. Naveen Mittal, trustee, Mr. Subrto, Principal and Mr. Amber and Mr. Rajdeep, Members of the school appeared before the committee and hearing was conducted. However, the documents were not sufficient, the hearing was adjourned. On 09/05/2024 this committee issued a notice and asked school to submit several documents and accounts details. On 14/05/2025, no one appeared before the committee and the hearing was adjourned. On 26/08/2025 this committee again issued a notice for physical hearing and also the accounts details to the school.
9. On 01/09/2025, Mr. Subrto Kunda, Principal, Mr. Jitendra Patel, Mr. Amber Bohara and Mr. Hitesh Patel, authorized persons of the school appeared before the committee and hearing was conducted. During hearing authorized persons

of the school requested to increase at least 20% in fees in each year. After perusing the documents submitted by the school. It appears that the strength of the students is 1207 in year 2024-25. It is submitted by the authorized person of the school that school had spent Rs. 4,29,69,680/- towards salary of the staff, in which, school has produced bank salary certificate issued by State Bank of India. The school had suffered a loss of Rs. 1,47,80,000/- in year 2024-25, to overcome that loss, school received the donation of said amount from its parent company. School has spent Rs. 20,17,414/- towards Housekeeping expense. School has also spent Rs. 19,23,003/- towards Repair and Maintenance expense. The total expenses of the school was Rs. 5,69,67,593/- and total Tuition Fee Income was Rs. 4,08,69,256/-. Hence, total loss was Rs. 1,60,98,337/-. Considering above facts, inflation rates, the amenities provided by the school and requests made by the authorised person of the school, this committee determine final fees for the year 2024-25, 2025-26 and 2026-27 as under:
